

As this year wraps up, we have made arrangements for our Annual Meeting to be the day before Valentine's Day; <u>Saturday, February 13, 2010.</u> Be sure to mark your calendar to attend this morning meeting. You will be receiving the Annual Meeting packet sometime in January.

The Board has been working on numerous projects, which will be covered in detail at the Annual Meeting. However, I would like to address here some areas and projects so you can be prepared for these topic discussions. Here are some of the major areas worked on by your Board in 2009:

Sea Walls & Entrapment Device:

We were instrumental in getting the City to re-start the repair of their sea walls, presently being worked. A progress report on the work being done and on the future of our sea walls will be given to you at the Annual Meeting. A fu

Seawall update

Much has changed since the seawall update was provided to you in the August/September issue of Currents. Back then, the City was on the verge of granting a new, multi-year contract to their current waterways consulting firm. The members of our CIWHA Waterways Committee expressed our views to the City. We believed this firm had provided less than satisfactory performance with respect to addressing the needs of the seawalls as well as with respect to their project management role in the most recent dredging episode.

We invited a principal partner of the engineering firm hired by the County of Los Angeles following the collapse of two seawall panels in Marina Del Rey. We provided this individual, along with representatives of the City, a tour of our harbor. The following day we all had a meeting with the City.

The good news, in the opinion of this industry expert, is that the seawalls are in relatively good condition based on their design and age. The better news is that along with the Committee members, the City was so impressed with our guest that they agreed to take the rare step of ter

minating the consulting contract award and commence with writing a new Request for Proposals (RFP). We just received word that the City is close to sending the Waterways Committee a draft of the RFP for our review and comments before it goes out to bid.

It became abundantly clear that what is needed is a firm that possesses the non-destructive testing capability along with analytical tools to assess structural strength and measure reinforcement steel corrosion loss in areas that cannot be visually seen. With this assessment and proper risk management, a comprehensive and higher confidence long term plan can be developed and then funded. Short and long term repairs are inevitable; however, we were pleasantly surprised when the industry expert mentioned a repair that was once considered unthinkable. That remedy would be to pour a new steel reinforced concrete wall attached to the front of the existing walls. Assuming that the existing foundation is sufficient for the loading, this properly designed and implemented remedy would be structurally and aesthetically superior to any major repairs. Ironically, the cost for this remedy was ball parked by the industry expert below some of the previously provided repair cost estimates from the City.

It appears that any plan of action involving only crack repairs will simply perpetuate the seawall issue and will likely lead to patched-up seawalls that are not just visually horrific, but seawalls that could adversely affect our property values. We remain optimistic that a long term plan will be developed that will provide sensible long term solutions palatable to a majority of homeowners from both cost and convenience viewpoints.

ture entrapment devise on the drain by Victoria and Hemlock similar to the device now installed on Channel Islands Boulevard identified as the "West drain" is being considered by the City, although nothing has been started as of this writing.

City Sea Wall & Dredging Tax

You may have heard of a new tax the City is trying to impose on Mandalay Bay and Harbour Island to cover the future repairs of their sea walls and their channels. The City wishes to levy this tax through a 15 year period. We have a committee negotiating with the City on this tax. The committee, composed of four people, has been working on this project for the last 2 years with the assistance of a very competent local lawyer, and I must report we have made great strides in our standing, i.e. ownership of the walls, etc. This committee of four has worked hard in the very best interest of our community. This major topic will be discussed in our annual meeting. Any questions or suggestions will be appreciated.

Special Meeting

A Special Meeting may be required in 2010 if the City has completed their part of drawing the agreement between Mandalay Bay and Harbour Island and the City of Oxnard concerning the City Tax levy. The Special Meeting will be set to discuss the procedures required for voting on the agreement. We will discuss in detail at the Special Meeting the total tax impact based on the final draft of the agreement presented to our Board.

I personally would like to thank the committee for the many hours spent on behalf of the Association, and I can guarantee you our community has been well represented and served.

Future Construction

The future development at Fishermen's Wharf, corner of Victoria and Channel Islands Boulevard, includes more construction of dwellings. We have been in contact with Supervisor Bennett's office concerning this project, and have been brushed aside. Also, the strip at Wooley Road and Harbor Boulevard is ear-marked for more dwellings. Also, we have heard rumors that a school will be built in the area. And if you have been involved in any prior developments in our area, you will recognize the phrase: "No Traffic Impact." We have heard this phrase for years and the traffic has been getting worse and worse.

Speed Limit & Sound Abatement Wall

Following the suggestion at the 2009 Annual Meeting in February, our Board has met with the City Manager and Traffic Engineers requesting the speed limit be lowered on Harbor Boulevard which will, in turn, reduce the noise level and let Meridian and Eastbourne traffic cross Harbor Boulevard. Since we are the only community on a major road that does not have sound walls, we were hoping that the City would compromise and lower the speed limit for the safety of our residents as well as lowering the noise level in our community, but the Traffic Engineers refused to help us in that regard. We will continue to pursue lowering the speed limit along Victoria as well as Harbor and the construction of a sound abatement wall along Harbor in view of the new construction being planned. I must add, however, that the City Manager has understood our problem and we have his support.

CC&R and Code Compliance

Your cooperation will be requested to assist your volunteer Board of Directors who need to adhere to the CC&Rs, and if you are notified of a violation such as boat trailers on your driveway, we would like to remind you this applies to not only to resident owners but also to tenants. As you know, our CC&Rs are very loose and when there is a violation, it takes a volunteer neighbor/Board member to perform a job that is of no financial gain. That volunteer is sometimes seen by violator-residents in a bad light for getting the CC&Rs enforced, thus maintaining the lifestyle and uniqueness of our neighborhood for the benefit of all.

We would like to address the City Code Compliance Department with respect to violations in our area that affect us, particularly commercial car washing on the streets, or on private property without the proper drainage entrapment devices which permit all chemicals they use to rinse directly into our harbor/back yards. Our development was not constructed the same way Seabridge and Westport were constructed. They entrap all street water through a filtration device; something we don't have the ability to do.
