### **President's Message**

This month not only ushers in a new year, but a new decade. With the new year comes hope for happiness, good health, and prosperity. While your Channel Islands Waterfront Homeowners Association board members are optimistic that will we continue to make progress in replacing the landscaping along Channel Islands and Harbor Boulevard, and continue to work with the surrounding homeowners associations and the neighborhood council to improve our water quality, we do not share that same optimism in regards to our seawalls.

Despite all our meeting with the City staff and our City Council members over the last decade, we are no closer to a solution for repairing our seawalls then we were in 2010. It has been frustrating to make progress with City staff members, only to see them depart, and start all over again with new leaders. We are now on our third engineering consultant, who has recommended a third strategy to repair the seawalls, at a cost that is more than triple the initial investment. Yet despite our frustrations, our current City manager, Alex Nguyen, and the head of public works, Rosemarie Gaglione, are close to finalizing a plan to address the repairs. However, the costs are significant, and the question of financial responsibility has not been resolved.

I encourage you and your neighbors to attend our annual meeting. The City staff plans to present their plan for repairing our seawalls, along with the schedule for landscape replacement. We will also have members of our community who will update the homeowners on the progress of protecting the water quality in our marina. We plan to ask for feedback from the homeowners on how they would like to proceed in our interactions with the City. We can continue with our current negotiations with the hope that our new City leaders will finally find a solution to our seawall issue, or we can consider the possibility of litigation, which in itself presents its own perils.

I hope you will be able to find the time to attend this year's annual meeting. I look forward to seeing everyone on Saturday, February 8th.

#### Seawalls

2019 Seawall Feasibility Study

As you may recall from last year's Annual Meeting Public Works director Rosemarie Gaglione had presented the launch of a new Feasibility Study to be completed prior to moving forward on additional Seawall Repairs and maintenance. The purpose of this study was to meet the needs of value engineering due to the scale and economics of this project as well as the changes in technology and engineering requirements and recommendations.

> The results of this study will be part of the presentation by the City.

#### Funding

The results of the feasibility study, landscape needs, dredging, water quality and inflation have increased the need for additional funding options.

### **Plans and Possibilities**

The City has approved for Public Works to apply for

The City's Special District coordinators are preparing options for potentially creating a new Community Finance District (CFD) specifically for Seawall Proj-

The City Manager has been very supportive to meet the understanding of a 50/50 split of seawall costs based on the public and private benefit. The final approval will be required by vote from the City Coun-

The issue for both the City and our special district is lack of funds.

The City has proposed creating a bond which would require approval by City Council and consent through a ballot measure by registered voters in Mandalay.

Alternatively and/or additionally homeowners may request to increase the current assessments to meet immediate and short term needs.

Your voice and your input and participation are crucial to this decision making and will impact all homeowners in Mandalay now and for years to come.

February 9, 2019

#### Call to Order:

The meeting was called to order at 9:00 am by President Bill Clark who then led the group in the Pledge of Allegiance.

#### **Honored Guests:**

Mayor Tim Flynn, City Manager Alex Nguyen, Public Works Director Rosemarie Gaglione, and District 1 City Councilmember Bert Perello were introduced.

#### **Review of Seawall Project:**

Bill Clark gave a visual presentation of the Zurn and Boise seawall designs including examples of deterioration. The recent history of the Waterway Capital Improvement Program involving TranSystems was reviewed. This project included refacing the seawalls and the estimated cost is \$90 million.

### **City of Oxnard Report:**

Mayor Flynn reported on some of the paving and other projects being performed by the City. The seawalls and harbor water quality are considered to be large challenges and require long term solutions. He believes he was elected "to do the right thing."

City Manager Alex Nguyen says he has spent his first six months cutting through red tape. His objective is to bring stability to the City organization. Employee turnover has been a serious problem.

Public Works Director Rosemarie Gaglione gave an update on the seawall repair project. She gave a description of the long-term failure mechanism of concrete. The TranSystems recommendations were reviewed. Rosemarie stated that due to the projected cost of the project a value engineering feasibility study had to be made. TetraTech will finalize the design concept through the feasibility study. The construction documentation is anticipated to take nine months to complete. The approved test project for repairing pilasters on Hemlock Street has been put on hold. Rosemarie believes there may be a better, cheaper and more long-lasting solution that what has been presented.

### **Harbor & Beach Community Alliance:**

Diane Delaney presented an update of H&BCA's activity in opposing the proposal for the large apartment complex on Fisherman's Wharf. The objective of H&BCA is to preserve public access to coastal land and to oppose harbor and beach development that is not in the interests of community and the environment.

#### **Closed Session for Members Only:**

The Consent Agenda included: Minutes of the 2018 Annual Meeting, the 2018 Treasurer's Report and the proposed 2019 Budget. All items on the Consent Agenda were approved.

### **Election of Board Members:**

Reelected to fill their expired terms were Bill Clark, Matthew Steinorth and Bob Freeland.

#### **Committee Presentations:**

Seawall Update: The role of the HOA Board is to monitor and be an advocate for the maintenance of the seawalls and channels. We are concerned about the feasibility study on the "steel sheet" method of repair. The City is using \$163,431 of our Waterways Assessment to fund this study.

Water Quality Update: The Nutrient Sampling Plan has been completed at 30 locations across the Harbor. Four remote sensors will be installed by the City in the Harbor. If a bad water quality situation is observed, report to 805 797-7598 or ciharbor@Oxnard.org.

Landscape Update: Dead trees have been removed and new ones planted in the buffer areas bordering the property. Irrigation system repairs have been made. Trees that are too close to the seawall may be removed. The Kingsbridge Lane greenbelt pilot project will continue. The landscape contractor has agreed to put more staff on property to improve supervision.

**Communications Team:** This team was created by a group of concerned homeowners to support our Board, generate updated information and provide visibility for our association with the City and County.
